What is a Smoke-Free Multi-Unit Housing Policy?



A smoke-free housing policy would protect residents living in buildings with 2+ units from drifting smoke from neighboring units (secondhand smoke) and the particles that settle on surfaces after someone has smoked (thirdhand smoke). This affects the health of the people who live in apartments, duplexes, or multi-family homes.*

Who is impacted?

All people are affected by smoke, especially families with young children, our elders, pregnant persons, and immunocompromised residents. Low-income people of color are more likely to live in multi-unit housing.**

Why we recommend San Francisco adopt a smoke-free housing policy

To protect the health of families and residents in multi-unit housing. By supporting a smokefree policy for multi-unit housing, we can prevent unnecessary exposure to smoke in our homes.

of survey respondents believe that a smoke-free policy in their building would benefit their family.***

Nearly half of respondents (48%) reported smelling smoke at least once per week.***
